## दिनांक 4 जनवरी, 2021 को ऑनलाइन आयोजित अभियांत्रिकी महाविद्यालयों की बीओजी बैठक के कॉमन निर्णय

- 1. तकनीकी शिक्षा विभाग के अन्तर्गत राज्य में 11 स्वययत्तशाषी अभियांत्रिकी महाविद्यालय स्वित्तपोषित आधार पर खोले गए थे। वर्तमान व विगत वर्षों में छात्रों की प्रवेश संख्या में लगातार कमी आने के कारण इनकी वित्तीय स्थिति के दृष्टिगत इन महाविद्यालयों को तकनीकी विश्वविद्यालयों का संघठक महाविद्यालय बनाने व ब्लाक ग्रांट के प्रावधान एवं शैक्षणिक स्टाफ एवं ब्रांच का रेशनलाईजेशन के प्रस्ताव वित्त विभाग को भेजे जाने का निर्णय लिया गया।
- 2. राज्य में अभियांत्रिकी महाविद्यालय, बांसवाड़ा में जनजातीय क्षेत्र के छात्रों को सुविधा उपलब्ध कराने के उदेश्य से गत दिनों माननीय मुख्यमंत्री द्वारा आईटी लाईब्रेरी की घोषणा की गई। माननीय मंत्री महोदय द्वारा इसी प्रकार से अभियांत्रिकी महाविद्यालय झालावाड़ एवं महिला अभियांत्रिकी महाविद्यालय अजमेर में भी आई.टी. लाईब्रेरी शुरू करने की कार्यवाही करने के निर्देश दिये। इसमें तकनीकी शिक्षा के साथ—साथ अकादिमक कॉलेजो के छात्रों को भी सुविधा मिलेगी। उक्त आईटी लाईब्रेरी की स्थापना का व्यय टेक्यूप—3 के अन्तर्गत किया जावें। इसके लिए संयुक्त सिचव, तकनीकी शिक्षा को नोडल अधिकारी लगाया जावें एवं इसमें एसपीए, टेक्यूप—3, जयपुर आवश्यक तकनीकी सहयोग देंवे।
- 3. कुलपित राजस्थान तकनीकी विश्वविद्यालय कोटा को टेक्यूप स्कीम अन्तर्गत IT based digital library समस्त affiliated colleges के benefit हेतु निर्देश दिये गये।
- 4. सभी अभियांत्रिकी महाविद्यालयों में टेक्यूप फेकल्टी / नियमित फेकल्टी की कमी को पूरा करने के लिए Subject Lecture पैकेंज की गाईडलाइन विभाग द्वारा तैयार की जाकर वित्त विभाग की सहमति प्राप्त की जावे।
